THE STATE BANKING SYSTEM

THE STATE BANKING SYSTEM

Among the most significant events of 1994, which are covered in greater detail below, were the following:

- The Banking Department joined with state banking regulators nationwide to develop a coordinated approach to adapt state regulatory systems to interstate banking and branching.
- An enhanced system for the supervision of foreign banks was introduced, including a new rating system for examinations.
- A statute was enacted which permanently deregulated interest rates on consumer loans and required banks to offer a low-cost checking account.
- A review of Banking Department fees indicated they were below, and often substantially below, those of the Comptroller of the Currency.
- Regulations were adopted governing the conversion of mutual thrift institutions to stock-form.
- Lenders were authorized to make reverse mortgage loans that enable elderly homeowners to tap into the equity of their homes.
- New supervisory procedures were adopted formalizing the process for applying for a license as a mortgage banker or registration as a mortgage broker.
- Outreach activities provided valuable education and technical assistance on the Community Reinvestment Act.

Adapting State Regulatory Systems to Interstate Banking

The Banking Department joined with state banking regulators across the nation to develop a coordinated approach to adapt state bank regulatory systems to interstate banking and

branching.

The Riegle-Neal Interstate Banking and Branching Efficiency Act of 1994 permits bank holding companies to acquire banks nationwide after September 29, 1995, and allows interstate branching for national banks after June 1, 1997, without any state action. States retain their current authority over the branching structure for state-chartered banks but may allow branching for both state and national banks before June 1, 1997, the so-called "opt in" provision, or prohibit interstate branching for all banks, the "opt out" alternative. State legislative changes will be necessary to enable New York state-chartered banks to take full advantage of the Act's authority to branch interstate.

The Conference of State Bank Supervisors (CSBS) in Washington is helping to coordinate state efforts to improve information sharing and cooperation among those already supervising multi-state banking organizations. The Banking Department is also developing ground rules for supervising multi-state banks and is distributing a workbook prepared by CSBS explaining the decisions New York and other states must make to respond effectively to the new interstate banking and branching law.

ROC-A Rating System

During 1994, the New York State Banking Department worked closely with the Federal Reserve and the Conference of State Bank Supervisors in developing an enhanced system for the supervision of foreign banks conducting business in the United States. This includes a new foreign branch and agency rating system known as "ROC-A", which stands for Risk management, Operations (including audit and internal controls), Compliance (with state and federal law and regulation, regulatory reporting and supervisory actions), and Asset quality.

This new report format uses the rating system and a detailed examination manual, developed to provide a uniform framework to be utilized in examining branches and agencies of foreign banking organizations. The program provides for a Strength of Support Assessment ("SOSA") to review the ability of the foreign

banking organization to continue to meet its U.S. obligations. Foreign banks which operate through multiple offices throughout the country will also have a rating assigned to their respective combined U.S. operations.

The goal of the regulators is to insure consistent supervision of foreign bank activities throughout the country. The ROC-A system has been revised from the previous rating system in order to better assess the condition of a branch/agency within the context of the foreign banking organization, as well as to pinpoint key areas of concern in a branch/agency office.

Low Cost Checking Accounts

The Omnibus Consumer Protection and Banking Deregulation Act of 1994, which permanently deregulated interest rates on consumer credit, required most banks and credit unions to offer low-cost, "basic banking" checking accounts in order to increase the availability of banking services to low and moderate income persons. The statute specified that account holders be allowed eight withdrawal transactions each month by check, teller or institution-operated ATM at no additional charge, and that no bank should be required to offer low-cost checking accounts at less than the actual cost to the bank.

After public hearings held by the Banking Department in Rochester, Albany and New York City, a new regulation was adopted by the Banking Board establishing the criteria for opening and maintaining such an account. This regulation provides that the initial deposit required to open the account shall not exceed \$25; the minimum balance requirement thereafter shall not exceed one cent; and the monthly fee shall not be greater than \$3.

Customers could be charged extra fees, however, if they make ATM withdrawals or deposits at electronic facilities not operated by their banking institution or if they exceed eight withdrawals per month. Customers who use other fee-based bank services will be charged for those services in the same manner as regular account holders.

The regulation, which went into effect on January 31, 1995,

also allows banking institutions to apply for permission to offer an alternative account or service which is at least as advantageous to consumers as a "basic banking" account. A number of institutions have applied, and received approval, for alternative accounts that are as good as, or even better for consumers, than that required by law.

Fees Charged to Banks

The Banking Department reviewed the fees it charges for various types of applications in light of the announcement by the Comptroller of the Currency that its fees were being reduced.

A comparison of these fees indicates that in almost every instance the Banking Department's fees are below, and often substantially below, the reduced fees that will be charged in 1995 by the Comptroller. The difference in application fees is particularly significant for mergers, new bank formations, changes in control, charter conversions, stock appraisals and new branches of foreign banks.

Conversions of Mutual Thrifts to Stock-Form

The Banking Board adopted amendments to its regulations governing mutual-to-stock conversions of savings banks and savings and loan associations.

The regulations were amended to address concerns that the appraised value of the converting institution might be understated and that insiders were receiving inappropriate financial benefits in the conversions.

Reverse Mortgage Regulation Adopted

The Banking Board adopted regulations for authorized lenders to make reverse mortgage loans that enable elderly homeowners to tap into the equity of their homes. The regulations implement the statute enacted in 1993.

The law provides that lenders may originate two types of reverse mortgage loans, a "280 loan" and a "280-a loan", and either

may be structured as term or tenure loans, the latter with no stated term. A 280 loan may be made to a person who is aged 60 years or older and has fewer statutory restrictions than a 280-a loan. A 280-a loan must be insured and may be made to a person aged 70 years or older who has an income no greater than 80 percent of the median county income. A 280-a loan also grants lifetime possession of the home to the borrower.

A unique feature of New York's regulation is that it allows lenders to recoup only actual costs of the sale of a property at the termination of the loan. Most states that allow reverse mortgages permit lenders to charge a flat percentage fee to cover their costs at the termination of the loan.

The Regulation further stipulates that mortgage bankers and others who offer reverse mortgages must have a minimum of \$10 million in capital. They must also secure from an unaffiliated entity an irrevocable letter of credit covering the amount anticipated to be needed to fund the reverse mortgage commitments of the lender for 12 months but not less than \$3 million. Lenders are also required to make as many 280-a loans as 280 loans. To ensure that the product will not affect the safety and soundness of insured state-chartered banks, the regulation limits overall investment in reverse mortgage loans to 10 percent of an organization's capital, undivided profits and surplus.

Supervision of Mortgage Bankers and Brokers

The Banking Department adopted new supervisory procedures regarding financial requirements for mortgage bankers and brokers and change-of-control reporting requirements.

In addition, the Banking Board adopted regulations for lock-in agreements and mortgage commitments that require lenders to include a list of all property-related documents and conditions typically required to be produced by an applicant. Further, in the case of mortgage commitments, lenders are also required to include all property-related and underwriting documents and conditions

foreseeably required to be satisfied by an applicant at the mortgage closing.

These new supervisory procedures formalize the process for applying for a license as a mortgage banker or registration as a mortgage broker. The new procedures list the information and documents required and specify how assistance in filing may be obtained. Procedures for change-of-control applications and applications by mortgage brokers for inactive status were also promulgated.

During 1994, the Department's Mortgage Banking Division and the Consumer Services Division obtained \$1.1 million in refunds for consumers.

Outreach Activities

The Banking Department conducted numerous outreach activities throughout 1994 to provide technical assistance and education to community groups as well as the industry on many issues including the Community Reinvestment Act and the dual banking system. Discussions generated valuable feedback and kept the Department apprised of new developments.

Representatives from the Department also visited banks throughout the state to clarify the examination process and to listen to their concerns. In conjunction with this ongoing dialogue, the Department was presented with proposals that generated further discussion on lending and investment possibilities for banks and community groups.

The link between the Banking Department and the community as well as the banking industry is vital to its success in meeting its mandate of preserving safety and soundness, and all outreach activities were formulated with this in mind.

Major Legislation in 1994

Several important Banking Law amendments were enacted during the 1994 session. In summary, these amendments:

- Provided for deregulation of consumer loans and increased consumer services by way of the following:
 - permanently deregulated interest rates on personal loans, credit cards (cash advances and purchases), checking account overdrafts, retail contracts, motor vehicle installment contracts, second mortgages, licensed lender loans and credit union loans;
 - permitted introductory rates and rate sales for credit cards as well as the imposition of fees for obtaining extra cards or a third replacement card for a customer's account;
 - established that permitted fees and charges, while not interest for purposes of the New York Penal Law, were nonetheless interest under New York Banking Law for purposes of certain Federal laws and that such fees and charges, as well as, interalia, the method of determining the outstanding balance, were material to the determination of the interest rate under New York law for purposes of "exportation";
 - required banking institutions to provide a basic banking account which offers at a minimum eight free withdrawals per month;
 - established a toll-free telephone service within the Banking Department from which New York residents can obtain comparative credit card rate information; and
 - prohibited a banking institution from having a policy or practice of refusing to open a deposit account solely on the basis of the geographic location of the depositor's residence or place of business.
- Provided for the establishment of two small business investment companies.

- Added the Motor Vehicle Retail Leasing Act which regulates the terms and conditions of retail motor vehicle leases, effective June 30, 1995.
- Allowed state-chartered commercial banks to pledge assets
 or furnish security for repayment of moneys held in the
 name of, or in trust for, any Indian nation and tribe, thereby
 placing New York banks in a position of parity with national
 banks.
- Expanded the authority of savings banks to invest in certain types of mutual funds.
- Allowed the foreign office of a New York commercial bank to participate in underwriting activities for securities issued by a political subdivision or instrumentality of a foreign nation, thereby placing New York banks in a position of parity with national banks and state-chartered banks of other states.
- Provided that a bank, trust company or national bank located in New York State shall not be required to repay any deposit made at a foreign branch of such bank if the branch cannot repay the deposit because of war, insurrection, or civil strife or foreign government action in or by the country in which the branch is located, unless the deposit contract expressly states that repayment will be made in such circumstances.
- Prevented the Superintendent from issuing a check cashers license, irrespective of community need, to a prospective licensee at a location which is closer than 3/10 of a mile from an existing licensee; and further provided that the primary business of the licensee at the location to be licensed shall be financial services.

Banking Department Budget

Total expenses for the operation of the New York State Banking Department were \$45,363,309.94 for the fiscal year 1993-94. This includes \$335,514.71 for the Office of Regulatory and

Management Assistance and \$527,804.05 for the Department of Law for the Crime Proceeds Strike Force.

Revenues from examination fees amounted to \$9,440,067.88. The balance was assessed to banking organizations and foreign banking corporations.

The final assessment rate was \$3.48627744 per \$100,000 of assets for all assessed institutions.

For fiscal year 1993-94, revenues of \$2,966,569.04 were collected for investigation, license, other fees and fines, and credited to the General Fund.

PUBLIC STATEMENTS OF THE SUPERINTENDENT OF BANKS

Reprinted below are certain speeches and statements made during the year by the Superintendent of Banks. They are reproduced here because they are part of the public record and contain matters of sufficient policy interest to be made available in this form

RESTRUCTURING THE BANKING INDUSTRY

Good afternoon ladies and gentlemen and distinguished guests.

We commemorate today the 100th anniversary of the founding of the New York State Bankers Association. It is a great milestone for this organization and, on behalf of the New York State Banking Department, I congratulate you. The Bankers Association has played and continues to play an exceedingly important role in banking, a very important sector of our state economy. You have zealously and effectively represented the interests of the banking industry without neglecting the wider public interest, and for that you have earned the respect of the Banking Department. I have worked personally with two Executive Vice Presidents of the Bankers Association -- Jim Murphy and Mike Smith -- and if their predecessors were of equal quality, it is easy to understand how the organization has survived and flourished over the years.

The New York State Bankers Association was founded in the year 1894. The banking system in existence during those times seems archaic by today's standards. There were 215 state chartered commercial banks in New York in 1894. Aggregate commercial bank assets totaled \$285 million. Total system-wide capital equaled \$33 million. You will recall that in those days the banks issued their own notes, and there was a total of \$78 million of such notes issued by New York state chartered banks in circulation at the end of 1894. The Banking Department's total annual budget was \$23,200, of which \$5,000 (that is, more than 20%) was allocated for the Superintendent's salary. It distresses me to know

that I would have made over \$8 million last year if the same percentage of the total Banking Department budget was allocated to the Superintendent's salary today. And best of all, the Banking Department has only 6 examiners! Now I know what the bankers means when they refer to the good old days.

Ten new banks were formed in 1894, among them the Bank of Holland and the Bank of Richmondville. A good many of the names of the other banks in existence in 1894 are no longer to be found in the roster of state chartered banks today. Not many of you will recall the Astor Place Bank, the Eighth Avenue Bank, the Far Rockaway Bank, the Fourteenth Street Bank or the Glen Cove Bank of Glen Cove, the latter so named I suppose to distinguish it from the Glen Cove Bank of some other town. Fewer of you may remember the Murray Hill Bank, the Lumber Exchange Bank, the New York Produce Exchange Bank or the German-American Bank of Buffalo.

Speaking of Buffalo, there was among the banks subject to examination by the Banking Department in 1894 the Manufacturers and Traders Bank, founded in Buffalo in 1856. As of August 20, 1894, M&T had \$5.5 million in total assets, capital of \$900,000 and undivided profits of \$550,000. Bob Wilmers will probably appreciate knowing that among the board of directors of the M&T in 1894 was one William Hamlin, no doubt a progenitor of our own George Hamlin.

Indeed those were very different times. There was a West Side Bank and an East Side Bank, with the West Side Bank being about 5 times the size of the East Side Bank. Even Alfred University, up in Alfred, New York, owned a bank. The Superintendent of Banks in 1894 was named Charles Preston. As you may know, the Superintendent each year is required to submit an annual report to the legislature as required by the Banking Law. It appears from the 1894 Annual Report that the Superintendent enjoyed only modest success with the State Legislature. The Report notes that the Superintendent had made several recommendations to the Legislature in 1893 with the Legislature had failed to act upon, much to the Superintendent's annoyance.

A number of significant issues of concern to the Superintendent in 1894 would be familiar to us today. I will share

one such issue with you, and that involves a proposal to restructure the responsibilities of the state and federal bank regulatory agencies. In hi s recommendations to the State Legislature, the Superintendent exhorted the legislators to recommend to the U.S. Congress the following suggestion:

Repeal the national banking act in all respects except the provisions relating to the issue of the currency and the securing of the same, so that all banks shall become State banks and subject to State supervision. There is no longer any good reason for the continuance of the national banks as such. There should be but on banking system in each State, as well as one system for the issuing of currency. At the present time, there is more or less contention and discrimination between the national and State banks. If they were all State banks they would all be entitled to be treated upon their merits. Greater thoroughness as to examination and supervision could be enforced if all the banks were State banks, for the reasons that then the territory would not be so large but that the supervising officer in each State could make his appointments of examiners from personal knowledge of the fitness of the person appointed, and would be personally acquainted and constantly in touch with his corps of examiners....

We should reflect a moment and realize that, while this glimpse into the past provides us with a certain amusement, it is also quite instructive. It offers great insight, I believe, into our present difficulties. We are now, as much as any other time in our history, at a critical juncture in the evolution and development of our domestic banking system. Decisions made and policies implemented in the next few years will impact our banking system well into the next century. Notwithstanding the record profits earned by banks in recent times, the U.S. banking system remains, I believe, fundamentally vulnerable to periodic crisis unless certain structural issues are addressed.

As we speak today, the U.S. banking industry appears to be

prospering. And indeed, measured by historical standards, the banks are doing quite nicely. But today's prosperity is, in my view, a temporary phenomenon. Since the middle of 1992, the banks have been the beneficiaries of a great gift: low interest rates or, more precisely, an unusually wide spread between short term rates and long term rates. This so-called "steep yield curve" was indeed a blessing. Earnings have been exceedingly strong, capital has been replenished and non-performing or classified assets have been written down or sold. Bank balance sheets are very healthy.

The problem with all of this is that very little of this success was achieved through traditional avenues of banking. Net interest margin from lending is not the primary source of the dramatic recovery of the banking industry from the unstable days of 1990 and 1991. Lending of all types as a percentage of the total volume of business conducted by banks has declined significantly in recent years. The opportunity for profits from the purchase and sale of Treasury securities will not doubt shrink, and when that happens banks will suddenly be forced to confront the harsh reality that the difficult regulatory issues have not gone away.

When the yield curve flattens, as it no doubt will, there will be a rather sudden squeeze on profitability for those banks that have relied on the Treasuries markets for their core earnings. Only the most nimble will be able to adjust quickly. For the remainder, earning will drop, not because of asset quality as in the past, but because gross expenses will not be adequately offset by revenues. Among other difficulties, stockholders will be disappointed in the returns on equity and, as you know, stockholders have effective ways of expressing their disappointment. The banking industry will be back in the familiar position of being slowly suffocated by the U.S. regulatory system, but without the oxygenation of the steep yield curve.

There have been periodic efforts in the past to restructure the U.S. banking system. The last time that it was attempted was in 1991, when the Bush Administration submitted to the Congress a comprehensive proposal to restructure the U.S. financing services industry — banking, insurance and securities — in a manner that would modernize and rationalize the system by dismantling the legal and regulatory barriers that separated the financial services

industries and by abolishing the bar on interstate branch banking. It appeared as if, at long last, the U.S. banking system would be restructured in a manner that would allow for far greater productivity, competitiveness and efficiency. But it was not be.

After many months of lobbying by the various industry groups affected by the proposal and jurisdictional warfare within the House of Representatives — punctuated by the BCCI scandal and well-timed references to the S&L debacle by opponents to the restructuring — the Congress flatly rejected all of the major elements of the Bush restructuring plan. Once again, efforts to put the U.S. financial services regulatory house in order failed at the last minute.

There are several reasons for this failure. First, the Bush proposal was perhaps "too" comprehensive and ended up drawing the opposition of many constituencies which had little in common with each other except opposition to some portion of the bill. Second, the support of the banking industry itself was fragmented, with the small banks, large banks and regional banks, at times, advocating different approaches.

However, the most significant reason why the proposal failed was far more fundamental: namely, because the American public does not understand banking as a modern day business and does not distinguish it in its present form from its historical antecedents. Again, if we look back to 1894, we see the roots of the current problems of the banking industry. Virtually every town in New York appears to have had its own bank. In Manhattan and the boroughs of New York City, there were a good number of neighborhood banks. Indeed, so close was the perceived connection between the banks and the general population that 11 banks in the State of New York went by the name of the "People's Bank" of the name of the town or city in which the bank was located.

It is the failure to understand and accept the fact that banking as a business has changed dramatically and irrevocably from its historical beginnings that helped kill the Bush Administration's reform legislation and that will continue to stifle any efforts to bring about comprehensive reform. Central to this problem is the fact that any legislation designed to aid the banking industry is often perceived of —by elected officials and voters alike —

as inconsistent with the public interest.

For the long term health of both the banking industry and the U.S. economy, banks must obtain greater regulatory authority to diversify risk. Nothing worries me more as a regulator than to see a concentration of assets in a few products or a few markets. There is a need for product diversification and geographic diversification. It will reduce overall risk, not increase it as some believe. And it will provide banks with enhanced opportunities for profit, which is essential to maintaining the safety and soundness of the system.

Under the current regulatory structure, U.S. banks are handicapped to such an extent that I believe that their long term viability is threatened. Let me briefly illustrate my point in two ways. First, given the significant risks inherent in making commercial loans, banks are increasingly finding themselves in a position in which they assume equity-like risks and receive debt-like returns. This accounts as much as anything else for the increasing number of banks which are foregoing lending except to their most creditworthy customers.

The second point I want to make is this. Given the combined effect of the Bank Holding Company Act, the Glass-Steagall Act and the Community Reinvestment Act, banks find themselves in the unenviable position of being required by law to serve some of the less profitable sectors of the financial services business and prohibited by law from serving the most profitable. Now, as you know, I am a firm supporter of CRA and I believe strongly that it should be applied to banks and vigorously enforced. But our enthusiasm for CRA should not blind us to the fact that other regulatory reforms are equally worthy of Congressional action.

The public clearly does not appreciate the critical need for reform. Many look to the obvious mistakes made by the banks in the 1980s and blame the banks for their own troubles. We may argue about whether or not this explanation is valid, but we can be certain that it is largely irrelevant to the resolution of the larger, long term issues facing the industry.

In addition, the public has been led to believe that because banks encountered difficulty in their core lending businesses,

diversification into other areas would be unwise. In fact, the opposite is more likely true. The inability to offer a wide range of products in addition to loans, such as securities and insurance products, and to gather deposits across state lines — in short, to compete fairly with non-bank financial services providers which are not regulated as banks — has caused almost as much harm to the U.S. banking system as any non-performing loan.

Until we address these longer term bank regulatory issues, the U.S. banking system will remain vulnerable to periodic difficulties of a systemic nature. In a market economy such as ours, banks serve as the principal depositories for both public and private funds, constitute the principal providers of credit to businesses and consumers and facilitate commerce by serving as the principal vehicle by which payments are made for goods and services. Thus it cannot be reasonably argued that economic prosperity is sustainable in the U.S. without a healthy banking system. Unfortunately, the public at large and many policy makers have failed to grasp the connection between bank profitability and the overall health of the economy. There is opposition to bank reform in some quarters because people do not want to be seen as "helping out the banks". The reality is that unless we "help out the banks", the banking sector will be in no position to finance broad and even growth throughout the economy.

The need for reform is so critical that, but for the current interest rate environment, we would now be facing serious difficulties. The United States has always responded to pressing societal needs once a crisis has been reached but we have not traditionally responded to such problems in the absence of a crisis. We should act now, before the crisis. Further delay in bringing about meaningful banking reform and the resultant further decline in our banks relative to their domestic and international competitors could take many, many years to repair.

In closing, let me say that the views which I have expressed today should come as no surprise. But unfortunately, I am discussing tomorrow's problem and there are, as always, pressing issues to address today. But I firmly believe that the policy makers and the legislators at both the state and federal levels should begin now the process of financial services industry reform. This process

must start with a concerted effort to educate the public as to the urgent although currently hidden need for reform in this area. Educating the public with respect to banking reform issues has been neglected by the banking industry and its allies, but all efforts at comprehensive reform will fail to win Congressional approval without prior public education and support.

In the areas of international trade and health care, we have witnessed the enormous value of public education. I am convinced that the same would be true with regard to bank reform, if only the same effort were made. The public simply does not understand that banking business and does not appreciate the need for reform. The banking industry is saddled with too much historical baggage to bring about meaningful reform without first educating the public. A failure to begin this process now will no doubt cost us greatly in the future. These are costs that can and should be avoided. Thank you very much.

CONVERSION FROM MUTUAL TO STOCK OWNERSHIP'

Good morning Mr. Chairman and members of the Committee. My name is Derrick Cephas and I am the Superintendent of Banks of the State of New York. I appreciate the opportunity to appear before the Committee today to present the views of the New York State Banking Department.

The issue of conversion of savings institutions from mutual to stock form ownership has commanded the attention of the banking industry for several months now. We in New York have had the occasion to review this issue in some depth recently and, in that connection, I would like to include in the record of this hearing a copy of a policy statement which my office issued yesterday. Finally, before I turn to the substance of my remarks today, I would also like to respectfully ask for the Committee's understanding of my desire to limit my remarks today to stock conversions in general and not to comment on any particular institution or any particular transaction.

Chairman Riegle's letter confirming my participation set forth several questions which the Committee sought to have addressed. I will address them individually.

I. Who owns a mutual institution?

Under New York law, no one "owns" a mutual institution. That is clearly the answer under New York law, and as far as I am aware, it is also the law in every other jurisdiction in the United States. A New York court, as recently as January 1994 affirmed this conclusion. Neither the depositors, nor the management and trustees nor the community "owns" a mutual institution. Because of this unique status, the responsibility, I believe, falls to the bank regulators to protect the public interest in the conversion process.

II. What parties, if any, should receive priority rights in a conversion?

I assume that the term "priority rights" refers to rights to subscribe for the stock to be issued in a conversion. Under New York law, in a public offering of stock in connection with a conversion, all persons or entities who were depositors of a mutual institution as of a fixed record date receive a priority to subscribe for shares of the stock to be issued in the conversion, subject to proration in the event of an oversubscription. In addition, these same depositors are vested with the authority to approve or disapprove of the conversion by voting for or against it at a special meeting of depositors called for that purpose. Under the circumstances, this process has worked rather well in New York.

There are, however, two instances under New York law in which depositors do not receive a priority in the purchase of stock. Both of these instances involve transactions in which the board of trustees of the converting institution has decided to enter into a sale of control conversion pursuant to which ownership or control of the converting institution is acquired by one or more persons. If the proposed conversion involves an institution in a weakened financial position (under 3% net worth), the converting institution is allowed to convert without providing depositors with a right to purchase the stock. If the converting institution has net worth of 3% or more, although depositors have no right to purchase stock in the

conversion, the converting institution must allow competing offerors to present bids to depositors for the converting institution on an equal basis. In sum, New York law provides for (I) depositor priority in the purchase of stock in all public offerings, (ii) depositor vote to approve or disapprove of conversions in all cases (except in failing bank situations), (iii) uncontested sales of control only in the context of undercapitalized institutions and (iv) contested sales of control in other contexts in which depositors approve the transaction.

In most cases, depositors should clearly receive priority rights to purchase stock. In an effort to facilitate the conversion of financially weak institutions and to add greater flexibility to the conversion process, we have deviated from this standard in the "sale of control" examples outlined above.

III. To what extent should management and insiders be allowed to participate in a conversion? Should they receive a preference over depositors?

By "participate", I assume that the question refers to the ability to purchase stock in the conversion. As I stated earlier, depositors in New York usually receive a priority to purchase stock in a conversion. To the extent that "management and insiders" are also depositors, they are entitled to purchase stock on the <u>same</u> basis as all other depositors. We believe this to be an equitable policy.

Although it has never in fact occurred, it is possible under New York law for "management and insiders" to "receive preference over depositors" in a sale of control conversion by purchasing stock in the converting institution without offering subscription rights to depositors. This transaction, however, could not be consummated without the prior approval of the depositors of the converting institution.

With respect to compensation payable to management and insiders as part of the conversion, the Banking Department has already proposed regulations that would require the compensation arrangements of management and the trustees to be reviewed for fairness to the converting institution and its depositors. This requirements is particularly important in view of the fact that in the

typical conversion there are no disinterested directors to review such compensation plans. While management and the trustees should be permitted to receive fair and reasonable compensation, including incentive compensation, for their contributions to the institution, the wholesale transfer of material amounts of the net worth of converting institutions to management and trustees should not be allowed.

IV. How effective is the current appraisal process in ensuring that the stock is priced at fair market value?

This is a rather complex question and one that is under the active review of the Banking Department. We believe that the appraisal process warrants significantly closer scrutiny and we hope to be able to work with the federal regulators in reviewing the appraisal guidelines currently in use. New York State requires appraisals to be completed pursuant to the OTS Appraisal Guidelines since we have not issued our own procedures in this area. Pending a review of the existing guidelines, we are considering supplementing the existing OTS Appraisal Guidelines for use in New York by (I) defining "pro forma market value" as the estimated market value of the converting institution immediately after the consummation of the planned conversion, after giving effect to the receipt of the new proceeds and to a reasonable "new issue discount", (ii) prohibiting the appraiser from employing an assumed rate of return on the conversion proceeds if the appraiser knows or should know that the converting institution will use the proceeds in a manner that will produce a rate of return in excess of the assumed rate and (iii) prohibiting the appraiser from basing the appraisal in whole or in part upon information received from the converting institution which the appraiser believes or has reason to believe, after inquiry and the exercise of its professional judgement, is inaccurate, incomplete or unreasonable.

V. <u>Do sufficient safeguards exist to ensure that the conversion proceeds are utilized productively?</u>

We believe that regulatory procedures in this area may well need enhancement. In that connection, we have proposed in our policy statement of February 24, 1994 that the board of trustees of converting institutions adopt a business plan prior to or

contemporaneous with adopting a plan of conversion, which business plan would be filed with the Banking Department and would set forth, at a minimum, (I) the institution's reasons for converting, (ii) its planned use of the conversion proceeds, (iii) its plans with respect to the payment of dividends and the repurchase of stock to be issued in the conversion and (iv) the anticipated effect of the conversion on the institution's traditional lines of business and its ability to serve its customers after the conversion. Generic business plans which rely upon extensive use of "boiler plate" language will not be deemed to fulfill this requirement.

VI. What issues are raised in merger conversions, and how should such proposals be evaluated?

Merger conversions raise a number of concerns, most of which have already been identified by the Committee in questions discussed earlier in my testimony. In general, merger conversions raise issues relating to fairness to depositors and preferences and financial benefits received by management and the trustees. However, the fact that depositors of the converting institution are allowed to subscribe for stock of the acquiring institution rather than of the converting institution is the principal issued raised by a merger conversion which is not present in a socalled "stand alone" conversion in which the converting institution issues its stock to the public. If the stock of the converting institution is priced at a "bargain" price as some have argued (which, of course, raises other issues), then the depositors who might have purchased stock in the conversion are deprived of the benefit of that bargain since in a merger conversion they are offered the opportunity to purchase the stock of the acquiring entity only. The other issue often raised in the merger conversion context involves the fact that the acquiring bank in effect is able to "purchase" the converting institution at no real cost. Many have complained about this aspect of merger conversions. However, prior depositor approval would be required, even in the context of a merger conversion.

As to our evaluation of S.1801 and our assessment of the effectiveness of current law in ensuring a fair and equitable conversion process, let me first make a few general observations. Conversions raise a number of enormously complicated policy issues. As regulators, we are faced with large financial institutions

with large capital bases which are owned by no one. Many constituencies lay claim to owning or having an interest in the net worth of mutuals, but the fact is that none of those claims have any basis in law. Converting from mutual to stock form is a legitimate business objective and has over the years allowed the thrift industry to raise billions of dollars of additional capital. I believe that we all should be supportive of that objective.

The narrow question then arises as to how best to regulate a thrift institution in its transition as it changes from mutual to stock form. As we have outlined in our policy statement attached to this testimony, there are a number of policy recommendations which we are considering. The rules and regulations applicable to conversions are and should be evolutionary in nature. As markets change and as corporate practices and other circumstances change, the regulatory system should respond to the changing circumstances. That is what we have attempted to do in New York at the regulatory level — to revise our conversion regulations in view of present day business practices and market realities.

As to this Committee's proposal to enact S.1801, first let me say that as a bank regulator, especially a state bank regulator, we as an institution would always prefer to be given the opportunity to resolve issues at the regulatory level and at the state level. I realize that this Committee and this body, for which I have enormous respect, have different institutional imperatives than the New York State Banking Department, and that our preferences may not be consistent with your governmental responsibilities.

Having said that, let me also say that I understand and appreciate the concerns which the Committee is attempting to address with S.1801. The issues which the Committee has focused on certainly need to be addressed and the Committee has rightfully, I believe, brought public attention to these important matters.

If the Committee and the full Senate proceed to enact S.1801, I would like to respectfully make two observations:

 I believe that significant flexibility should be maintained at the regulatory level. There are many judgements to be made in the conversion process and, while the Senate certainly has the expertise to make such judgements, the regulatory apparatus is less cumbersome and is able to respond more quickly than legislative bodies in this regard.

2. As to the proposed Treasury Department study, I would respectfully suggest that the Committee consider shortening the time period called for in the study from 1 year to 6 months. There is currently a cloud of uncertainty hanging over the entire field of conversions, which should be removed as soon as practicable. While the subject matter of the Treasury study is important, it is also important that the study be completed on an expedited basis so that those banks which determine to convert can continue to do so with the minimum of regulatory uncertainty. The public market for converting thrifts has been exceedingly hospitable in recent times, but no one knows how long it will remain so. Care should be taken not to impede the conversion process more than necessary to address legitimate supervisory and regulatory concerns.

I appreciate the opportunity to appear before the Committee today and I hope that my comments have been useful to the Committee in its deliberations. Thank you very much.

SERVING LOW AND MODERATE INCOME COMMUNITIES'

Good Morning. My name is Carmine Tenga. I am Acting Superintendent of Banks and I am honored to have been invited to appear today before the New York State Assembly Committee on Banks to discuss the issue of "Access to Financial Services in Lowand Moderate-Income Communities." This is an important issue and one we at the Banking Department have been deeply concerned with for a number of years. Chairperson Greene, I commend you and the committee for helping both regulators and industry representatives to focus on this issue, and hopefully achieve a consensus on how to improve banking services in low and moderate income neighborhoods.

I believe that New York State has taken a giant step in the right direction. Passage of the Omnibus Consumer Protection and Banking Deregulation Act of 1994 by the state legislature has given us a mandate regarding lifeline banking, and the Banking Department is in the process of implementing its provisions.

We have issued for public comment the Department's proposed new "basic banking" regulation that will require state-chartered banks (and federally-chartered banks, on a voluntary basis) to offer low maintenance, no-minimum balance checking accounts with eight free withdrawal transactions. We also are fully supportive of the law's prohibition of discriminatory geographic service limitations — like the so-called 10-block rule — that may have been used selectively to bar some customers who lived or worked outside a banks' service area from doing business with that institution.

Nevertheless, "lifeline" or "basic banking" assumes that there is a financial institution within a reasonable distance of one's home or job that will provide this service. But, we have been asked: "How can people for whom basic banking is intended take advantage of this important product when there are net closings of bank branches across the state?" We agree that these closings can work a hardship on those who live and work in low and moderate income areas, particularly on senior citizens, and on the local businesses that operate in these communities.

The Banking Department has an established procedure for processing branch closings. Banks are required to notify both the Banking Department and their customers in writing 90 to 180 days prior to the official closing date. They also must provide notice regarding which new branch will service the accounts of the closing branch. The Department's Community Reinvestment Monitoring Unit (CRMU) reviews each closing to determine if sufficient banking services exist in neighboring locations to serve those customers affected by the branch closing.

On several occasions in recent years, the CRMU has actively participated in discussions with banks and community groups to keep branches operating until satisfactory arrangements could be worked out, providing at least limited banking facilities.

Among the forms this took were bank funding and temporary management assistance to establish a neighborhood credit union; agreeing to sell a branch to a de novo bank, and purchasing a minority stake in it to help make the new institution viable; or continuing to maintain a limited branch providing local deposit and ATM facilities. Some of these efforts were successful and some were not, but it should be emphasized that the active interest of city, state and federal elected officials, and local business and community groups, play a vital role in the successful conclusion of any such discussions and negotiations.

State and federal CRA regulations emphasize the need to maintain basic banking services in low and moderate income areas, and those banks that do so receive recognition in their ratings. For instance, a large New York City thrift that is part of Buffalo bank holding company earned CRA credit for purchasing and operating bank branches in East Harlem that otherwise would have been closed. And, to illustrate the system works both ways, another bank received a reduced rating after it closed a Bronx office in a low and moderate income area.

Institutions that offered lifeline accounts before they became a legal requirement also earned CRA credit, as did banks that scheduled special banking hours and provided services specifically tailored to low and moderate income customers and small businesses.

One bank has even contemplated the possibility of opening a special check cashing window in some low and moderate income branches to better serve those needing limited banking services.

The use of CRA, more specifically, the CRA protest, has become a useful tool for consumer groups to secure concessions from merging banks, concessions that may include continued maintenance of branches in specific disadvantaged areas.

Both state and federal regulators also have new CRA proposals pending that stress the importance of adequate banking services in low and moderate income areas, as well as increased reinvestment to meet the ordinary credit needs of individuals and businesses.

The Banking Department's original proposal would establish new quantitative and qualitative criteria to better measure CRA performance; specify a menu of services and investment options that qualify for CRA credit; authorize community involvement in the CRA examination process and publication of CRA ratings; and offer banks immunity from CRA protests if they earn outstanding CRA ratings for three successive years.

While we may proceed with some facets of the state's CRA proposal in coming months — particularly that dealing with community group involvement in the CRA examination process — final adoption will await promulgation of federal CRA regulations.

It has been our stated intention that both state and federal CRA regulations must be basically in sync if we are to avoid costly reporting requirements and other onerous procedures that might put state-chartered banks at a competitive disadvantage with federally chartered banks.

Today, consolidations and mergers are a driving force behind branch closings. It simply doesn't make good economic sense for merged banks to maintain branches in close proximity to each other when these branches provide similar retail and small business banking services. Such was the case with Chemical Bank and Manufacturers Hanover Trust Company. Chemical has closed 100 branches since its merger was consummated in June 1992. This scenario is also being repeated with other banks in Buffalo, in Albany, in Syracuse, in Rochester, in every large city where consolidation of financial facilities is in full swing. These closings generally eliminate duplicate facilities without necessarily causing inconvenience to the public in the local areas.

To the extent that the lack of banking facilities remains a problem in low and moderate income communities, I suggest we seek new ways of providing banking services for low and moderate income residents.

The new community development banks that will be organized under new federal banking legislation might serve as models for comparable state institutions.

In addition, community development credit unions could meet the needs of low and moderate income neighborhoods, but sufficient seed money is often lacking. Perhaps public funds could be used for this purpose.

Limited purpose branches located in retail outlets, such as supermarkets -- where people shop almost on a daily basis -- are another possibility. Such branches are becoming increasingly popular in some upstate counties and throughout the nation.

Check cashers and money transmitters are also providing necessary services in low and moderate income areas, and their mushrooming growth in recent years attests to the financial needs that exist, and must be met, in certain communities.

Even these suggestions tend to emphasize bricks and mortar and the traditional ways of doing our banking business. Electronic banking and banking by telephone are options that are readily available. Indeed, government agencies and the banking industry should encourage their clients, customers and vendors to consider direct deposits, and to utilize their telephones to transfer funds and access account information.

This, of course, presupposes potential low and moderate income customers can even open accounts.

After we issued our basic banking regulation for public comment, our Department received a call from a citizen who complained that "basic banking" was a sham. What was needed, he said, was legislation to require banks to open accounts for all persons whether or not they can provide documented proof of residency, employment, or what banks call valid identification.

The views expressed by this caller may be extreme, but they do contain a kernel of truth. Because of their legitimate concern for safety and prevention of fraud, banks do rely on standard documentation and they may be turning away potential customers who could one day become valued customers.

Not too long ago there was an article in the Wall Street Journal about a pilot program for homeless Vietnam War veterans

at Chase Manhattan Bank. The bank opened regular checking accounts for these individuals based on having their monthly welfare and disability payments deposited electronically. The results were striking with most accounts accumulating substantial balances, and the individuals themselves becoming "bankable," even "credit worthy" for the first time in years. It was an experiment, and it worked! And, what was once a pilot program is now a regular, ongoing program at the bank.

I suggest that banks should reflect on the Chase program and consider the feasibility of bending some of their requirements for opening "basic banking" accounts to encourage low and moderate income individuals who have not used banks before.

The accounts of low income — even moderate-income customers — are often viewed as high cost business by traditional banking institutions that depend greatly on individual and business customers who maintain relatively large balances or can afford the service fees.

The introduction of "basic banking" accounts, coupled with implementation of some of the expanded service options I've mentioned, could open up a large new market, with sufficient deposit volumes to earn a profit, and reduce high service costs.

In summary, I believe the health and vitality of our communities depend in large measure on the availability of banking services. In addition to working with the banking industry on this critical issue, we should encourage other purveyors of financial services to establish themselves in communities where their need is the greatest. In this regard, it would be helpful if public funds supplied at least a portion of the capital for de novo community development banks and credit unions.

That concludes my remarks. I will be happy to answer your questions.

CURRENT ISSUES IN BANKING

Good morning. It is indeed a pleasure to join with you at your 1994 annual convention in this beautiful Arizona setting. Many of you may recall that at one time I was Deputy Superintendent in charge of the Thrift Institutions Division. I left that position in the spring of 1991 in a departmental rotation of deputies. It's amazing how the financial landscape for New York savings banks and savings and loan associations has changed in the past three and one-half years!

In 1991, the industry was nearing the end of a major trauma that destroyed some historically important franchises and many institutions were suffering under the burden of serious loan portfolio problems. And some are still dealing with the residuals of that problem. Today, the industry is as strong as I can recall. Capital is sound, earnings have rebounded, asset quality has been strengthened and the prospects for the future are indeed promising. Let me bore you with just two statistics:

For this purpose I asked our statistical people to combine existing New York State chartered savings banks and savings and loan associations. At December 31, 1990, the combined group had a weighted leverage capital ratio of 6.9 percent, and an annual return on assets of .20 percent. At June 30, 1994, the capital ratio was 9.2 percent, and the return on assets was 1.04 percent.

From my perspective, the future looks inviting. However, one constant characteristic of the future is its uncertainty, and it is that uncertainty that will test your skill and resolve.

I remember the difficulties the industry faced a decade and a half ago when interest rate deregulation created a structural imbalance in the financial condition of many thrifts that had not anticipated the possibility of so radical a change in their operating environment. Similarly, a decade later, the industry, in part fueled by the addition of large amounts of capital gathered through

conversions to stock form, participated in and was injured by commercial and real estate toan excesses. Appraisals were not realistic; underwriting standards were liberal; and a competitive fever had too many lenders chasing too few good loans, thus contributing to the inevitable collapse.

The history of the two last crises, coming approximately a decade apart, suggests that the stability that had been the hallmark of thrift banking and indeed, banking in general, from the mid 1930's to the mid 1970's, is gone forever.

The protected financial marketplace that began to disappear in the mid 1970's was in fact an inefficient anachronism inappropriate for a modern American economy. Innovation, competition and dynamism are the characteristics of the present and future financial marketplace. The critical challenge to the elected government, to the regulators and to the managers of financial institutions is to interact to optimize the potential economic benefits of a fast-changing competitive environment.

Government must allow the thrift industry the organizational and product diversity necessary to compete effectively against a whole host of financial service providers. Supervisors must revise and improve the oversight mechanism in order to relieve supervised institutions of burdensome and unwarranted regulation and, at the same time, achieve an oversight presence that provides almost real time recognition of developing problems with individual institutions and adverse macro trends. Financial managers must take the long view.

It is a given that the normal business cycles of a free enterprise economy will include periods of correction that will test the fundamental strength of any financial institution. Competition and the appropriate concern for the bottom line will tempt managers to pursue opportunities whose benefits may prove to be illusory. Mistakes will be made. It is entirely reasonable to expect that not every business strategy and lending decision will be correct.

It is important that an attempt be made to assess realistically the inherent risk of any business strategy or investment decision in a variety of potential financial and economic scenarios. This will become increasingly difficult to do as the economy and the financial markets continue to grow in complexity and sophistication. But the institution that fails to establish an effective risk assessment attitude as a part of its corporate culture is inviting peril.

One current illustration relates to derivatives. Much has been written about them and their arcane nature and how they have. in some instances caused harm to some customers, securities firms, The level of concern at this time appears disproportionate. We should remember, however, that it follows almost on the heels of the real estate market collapse and the interest rate mismatch just a few steps before that. Those of us who have been around awhile snap to attention the moment we hear of a creation that has the potential to cause harm. The jury is still out on derivatives and only time will tell if they will have the negative impact of the same magnitude as the real estate collapse or the interest rate mismatch. I believe they will not. Their use as a hedging technique has a legitimate purpose. Their use as a speculative vehicle - sometimes masquerading as a hedge - has the potential for enormous profit as well as incalculable loss. There is protection only in a clear perception of the risks.

The lesson to be found in derivatives, as in real estate loan problems, or interest rate mismatches, or IBOs, or in financing mergers and acquisitions is universal. Banks must be managed with a thorough understanding of the risks attendant to their activities. That responsibility rests ultimately with the board of directors or trustees.

I am aware that many in this audience are board members who struggle with the difficult task of creating and implementing a vision and a strategy to achieve financial success at your institutions. It is not an easy task and is becoming less so. I would exhort you to be skeptical of the financial product or investment that is popular at the moment unless your own understanding of its purposes and risks gives you an adequate level of comfort. Do not permit your institution to dive into uncharted waters because the bank down the street seems to be swimming profitably with the tide. An unseen current might overtake both of you.

Adding to the natural uncertainty of the future is the recent

legislation approving interstate banking. It will take some time to discern how this will play out. I suspect, however, that it will have a generally positive impact both for banks and the public. As you are probably aware, there is an "opt out" provision that would permit individual states to exempt themselves from interstate branching. This will certainly not be the case in New York which, as the financial center of the entire world, has experienced the benefits of competition and relatively unfettered ease of entry. We have long had reciprocal interstate banking legislation on our books.

To the extent that interstate banking will enhance the opportunity for diversification of both funding sources and investments, it should prove useful in ameliorating major problems caused by local or regional economic downturns. On the other hand, it may increase competition for some institutions. Major consolidations will likely occur on the national and regional levels. I would expect that community banks that have a well-defined market and an appropriate business plan and that choose to remain independent can withstand almost any competitive threat.

I am aware of the critical mass argument that talks of size being important to attain market penetration and economies of scale. I do not disagree with that thesis as far as it goes. However, I do believe that size is not an absolute necessity for, nor a guarantee of, success. There will always be room for the crafty niche players.

The Banking Department is conducting a review of the potential impact of interstate banking on our regulatory mission. It is our goal to construct an apparatus that will provide a comprehensive and cooperative supervisory framework for state-chartered institutions doing business across state lines. We believe that we can achieve a regulatory protocol that will preserve and even enhance the value of a state charter in a nationally integrated banking marketplace. We are confident that at the end of the day the challenges raised by this new opportunity will be successfully addressed.

The question of corporate structure of your institutions has also been addressed. On October 13, the New York State Banking Board approved for final adoption amended general regulations

covering the conversion of mutual savings banks and savings and loan associations to stock form and the creation of mutual holding companies. These amendments had been in the works for quite some time and had been exposed to the comment process. (We are aware that the OTS and the FDIC are about to issue final rules governing conversion.) It is our intention to compare the federal requirements with our own and, where appropriate, propose amendments to our regulations in order not to disadvantage state-chartered institutions and achieve, where possible, an appropriate level of parity.

On the subject of conversions, I continue to believe that the stock conversion option will be an attractive vehicle for an institution that has a desire to expand its possibilities and garner additional capital. I am pleased that the mutual holding company option appears to be gaining favor since it permits an institution to raise an incremental amount of capital consistent with the needs of a defined business plan. I am not suggesting that full conversion is in some way less attractive, but an institution that chooses that route should have a reasonable business strategy to effectively deploy all of its new capital.

I would also reiterate that an institution of mutual form that is not in need of additional capital and whose board has made a good faith determination to remain mutual will not be pressured to convert by outside interests. That is our policy, that is our belief, and we are determined to enforce that interpretation.

You may also be wondering whatever happened to the Department's CRA proposal. It was not our intention to finalize an amended CRA regulation while there was a possibility that the federal regulatory agencies would issue a national standard. To do so would disadvantage our institutions and cause confusion and unnecessary organizational time and expense to gear up for a program that might, in some ways, contradict another imperative. We believe that our CRA initiative has been successful in furthering rational dialogue on this important issue and has, to some extent, served as a catalyst for the federal discussion. When the federal proposal is finalized, we will review our CRA regulation to determine what modifications are necessary to achieve a harmonious regulatory approach to this issue.

We continue to believe that the vast majority of our institutions observe their community lending responsibilities in a fair and forthright manner. We hope that the federal regulation eventually adopted will provide clear and consistent standards of performance that can be objectively applied and consistently evaluated by all parties to this issue.

An important action taken at last month's Banking Board meeting was the adoption of a "basic banking" regulation. This involved setting criteria for a bank account to be used by those with limited financial resources. The regulation, which had very little discretion in its formulation because of directives in the statute, calls for an account with a maximum \$25 opening balance, a one cent minimum balance, a maximum of eight check or onsite ATM withdrawals a month and a monthly fee of \$3.

The \$3 fee created the most controversy with our banking constituents during the comment process. We are sympathetic to the concerns expressed, but it was difficult for us to establish an initial monthly fee in excess of \$3 for several reasons. One reason is that two nearby states, New Jersey and Massachusetts, subscribe to a \$3 monthly fee for this type of basic account. Another, and perhaps more important reason, is the fact that no commentator produced a scientifically convincing presentation of what the average cost is to service a basic banking account. In adopting the \$3 monthly fee, the Banking Board requested that the matter of reasonable cost be revisited within 18 months. In the meantime, an institution which can demonstrate that its cost for maintaining a basic banking account is in excess of \$3 will be permitted a higher monthly charge. The opportunity to offer a comparable product is a second option open to individual banks, as you know.

Some controversy has also developed concerning the Justice Department's involvement in fair lending as demonstrated by the settlement with Chevy Chase Federal Savings Bank. Moreover, the Justice Department and the Federal Reserve Bank appear to have different views on the lending practices of Barnett Banks Inc. and several of its subsidiaries.

I am not familiar with and have no comment on the specifics of either instance. However, I am somewhat concerned that

additional regulatory elements are being introduced into the type of matter that has been traditionally administered by the banking agencies. Yet another federal overseer, without an historical track record and with perhaps different standards of evaluation, will obviously increase the level of uncertainty concerning lending and the law. The lack of consistency in administering this area may prompt individual institutions to develop competing programs that might dissipate their desired effect.

You may notice that I have referred to protecting a state charter in the context of interstate banking, mutual to stock conversions and CRA. I do so because I am intellectually convinced of the absolute importance of maintaining a banking system that provides for alternatives. The absence of a viable state alternative would, I believe, engender a monolithic regulatory apparatus that could stifle the creative energy in the banking system.

In order to keep the dual banking system as a worthy and realistic concept, the state charter must not carry with it unwarranted jurisdictional baggage and a state banking department must have a supervisory presence and expertise equal to its responsibility. I am pleased to say that the New York State Banking Department is equal to its task and I pledge that we will continue to maintain that posture. The history of regulation in New York has always been characterized by a constructive relationship between the Banking Department and our constituent financial institutions that benefited the citizens of our state. There is no valid reason that this should not always be so.

Before concluding I would like to observe that the last couple of years have been extraordinarily good for the banking industry in general: margins and profitability have hit historic levels and capital appears to be ample. Has there been or is there now a better time to store up reserves for the inevitable day when they will be needed? It is an opportunity that should not be passed up.

Thank you so much for inviting me and I look forward to meeting as many of you as possible in the short time that I am here. I hope and trust that you will have a very successful coming year and perhaps I can join you at your 1995 annual convention.
