1976 COLLEGE OF ELECTORS

THE 41 MEMBERS comprising the College of Electors, meeting in the Senate Chamber of the State Capitol in Albany on Monday, December 13, 1976 carried out a procedure mandated by the Federal Constitution to cast the electoral votes of New York State for President and Vice President of the United States.

The Electors, chosen by the Democratic Party, had been certified by the New York State Board of Canvassers, to be the choice of a plurality of the voters of the State.

The members of the College were convened by Secretary of State Mario M. Cuomo, and the proceedings began with an invocation offered by the Reverend Robert E. Roos, Chancellor of the Roman Catholic Diocese of Albany.

From the certified list of Electors, Secretary Cuomo called the roll of names. There were four vacancies. In order to fill the vacancies, the College elected temporary officers.

The Honorable Stanley Makowski of Erie County was named unanimously as the Temporary President; the Honorable Mildred A. Snyder and the Honorable Philip D. O'Donnell were named unanimously as Temporary Secretaries.

The College thereupon elected substitutes for the absent Electors.

Upon filling the vacancies, the College unanimously elected His Excellency, Governor Hugh L. Carey, as Permanent President of the College.

Governor Carey then addressed the College.

The Governor said that while the convening of the College was a ceremonial function under the Constitution, it was also a time to reflect upon the performance of a high duty as citizen electors, involved and engaged in the exercise of constitutional responsibility. He said the Electors were articulating the voice, the votes, of the people of the State of New York, who have indicated their preference for their President and Vice President of the United States.

"At least for the short moment we are, therefore, involved in articulating the voice of the people, but more importantly in the transmission of a trust, the high trust of the greatest public office in the world."

The election of the Honorable Abraham D. Beame and the Honorable Margaret Costanza as Permanent Secretaries followed Governor Carey's address.


In the formal ceremony of balloting for President and Vice President of the United States which followed, the 41 electoral votes of New York State were recorded for Jimmy Carter of Georgia for President and for Walter F. Mondale of Minnesota for Vice President.

Each Elector inscribed the ballot he cast for President and Vice President, then signed the formal Certificates of Election. The ballots will be returned to the Electors as personal momentos while the Certificates were directed to be filed with the appropriate federal, state and judicial officials as required by law.

Rabbi Martin Silverman, President, Capital District Board of Rabbis, delivered the benediction.

Governor Carey closed the proceedings, after which members of the College of Electors were taken to the Executive Mansion for a reception as guests of the Governor.

Proceedings of the Electoral College of the State of New York, held in the Senate Chamber of the State Capitol, Albany, New York, on Monday, December 13, 1976, commencing at twelve o'clock noon.

MORNING SESSION

HONORABLE MARIO M. CUOMO, Secretary of State, Presiding:

Ladies and gentlemen: It is my privilege as Secretary of State to call to order this meeting of the Electoral College of the State of New York.

These proceedings are dictated by the Constitution of the United States, statutes of the State of New York and the accretion of long established tradition.

The actions of this Electoral College will constitute this State's effective participation in the election of the next President and Vice President of the United States. As such, it culminates the most important function, in the most successful system of elective government this world has ever known. Recognizing that, the convening of the College and its brief deliberations, have always been regarded by the State of New York as a serious but joyful celebration of the American political system.

Now, to commence these proceedings, I am honored to be able to present to you Reverend Robert E. Roos, Chancellor of the Roman Catholic Diocese of Albany to deliver the invocation.

DIVINE BLESSING—REVEREND ROBERT E. ROOS:

Heavenly Father, we thank You for the 200 years of life You have bestowed upon our nation. We ask Your blessing upon this gathering today and upon all who participate in the governmental process. With Your help and guidance may we be enabled to achieve more fully our ideals of unity with diversity, of peace with justice, of order with liberty, and we pray that what occurs here today will find its fulfillment in Your plan for all mankind.

In Your name we pray. Amen.

Thank you Reverend Roos.

HONORABLE ALICE SACHS:

Mr. Chairman, it is my honor to present the name of the Honorable Stanley Makowski of Erie County for Temporary President of this College.

SECRETARY OF STATE CUOMO:

The Chair recognizes the Honorable Joseph J. Sweet of Steuben County.

HONORABLE JOSEPH J. SWEET:

It is my honor and pleasure to second the nomination of the Honorable Stanley Makowski for Temporary President.

SECRETARY OF STATE CUOMO:

The Honorable Stanley Makowski of Erie County has been nominated as Temporary President of this College. Since there are no further nominations I ask those in favor of the election of the Honorable Stanley Makowski as Temporary President of the College to signify this by saying aye. (Chorus of ayes) Opposed? (None) The members having voted unanimously in favor, the Honorable Stanley Makowski is declared elected.

I now ask the Honorable Robert Tierney, Assistant Counsel to the Governor, to escort the Temporary President to the Chair.

(Whereupon, the Temporary President was escorted to the podium.)

SECRETARY OF STATE CUOMO:

Ladies and gentlemen, I am pleased to present to you your Temporary President, the Honorable Stanley Makowski.

TEMPORARY PRESIDENT MAKOWSKI:

My fellow electors: I thank you for the honor and privilege of serving as your Temporary President.

As members of the Electoral College, I ask all those who have been elected to come forward and Secretary of State Mario M. Cuomo to administer the oaths of office.

(Whereupon, the oaths of office were duly administered and oath forms signed and delivered and the new electors took their seats.)

Thank you. The Electoral College now consists of its full complement of 41 members. We now turn to the election of a Permanent President of the College and I recognize the Honorable Francis J. Barry of Bronx County.

HONORABLE FRANCIS J. BARRY:

Mr. Temporary President, it is my privilege, pleasure and honor, to nominate as Permanent President of this Electoral College His Excellency, the Honorable Hugh L. Carey, Governor of the State of New York.

TEMPORARY PRESIDENT MAKOWSKI:

I now recognize the Honorable Donald S. Harrington of New York County.

HONORABLE DONALD S. HARRINGTON:

I am pleased and honored to second the nomination of His Excellency, Governor Hugh L. Carey, as Permanent President of this College.

TEMPORARY PRESIDENT MAKOWSKI:

There being no other nominations, I would ask all in favor of the election of the Honorable Hugh L. Carey as Permanent President of the College to indicate such by saying aye. (Chorus of ayes) Opposed? (None) I declare the Honorable Hugh L. Carey unanimously elected Permanent President of the College.

I now appoint the Honorable Fred W. Stabbert of Sullivan County and the Honorable Aileen B. Ryan, Bronx County, to escort Governor Carey to the podium.

(Whereupon, the Governor was escorted to the podium.) (Applause)

TEMPORARY PRESIDENT MAKOWSKI:

I am honored and delighted to give you your Permanent President, the Honorable Hugh L. Carey.

PERMANENT PRESIDENT CAREY:

Thank you, President Makowski and electors of the Electoral College.

This is a time, indeed, of important ceremonial function under the Constitution of the United States of America, but as important as is our ceremonial function, let us also reflect that we are carrying forth our constitutional duty as citizen electors as persons, according to the rules that govern the conduct of affairs of the United States. In our public affairs, our rules are those of the Constitution and, therefore, we are today involved and engaged in the exercise of constitutional responsibility.

As we act, we articulate the voice, the votes, of the people of the State of New York, who have indicated their preference for their President and Vice President of the United States. At least for this short moment we are, therefore, involved in articulating the voice of the people but more importantly in the transmission of trust, the high trust of the greatest public office in the world.

The duties and responsibilities of the President and Vice President of the United States are set forth in the Constitution. By our powers today, we cannot enlarge or increase those powers or responsibilities, but by acting according to the duties assigned us, as duly elected persons, we do add to this process.

The regularity of our system of laws, which today in this bicentennial election year, marks another precedent in the progress of the young and vigorous republic of which we are all citizens and today member electors.

When we have concluded this proceeding, we will have duly certified to our government in Washington that the people of our State have chosen and we will indicate their preference. Let us also in that solemn moment at the conclusion of our function, each unto himself or herself, add something on which this Constitution of the United States is based.

The hope, indeed the prayer, that by our actions as citizens and persons and voters we have sent to the high office of President and Vice President those in whom we place our trust and with those persons our prayer that we shall have in the years ahead the great guidance of the Creator of our country and our Constitution, which is a great resource of our people. (Applause)

Let us now proceed with the next order of business, the election of Permanent Secretaries of this Electoral College.

I recognize the Honorable Anna Jefferson of Kings County.

HONORABLE ANNA JEFFERSON:

Mr. President, and ladies and gentlemen, it is my pleasure to present the names of the Honorable Abraham D. Beame of New York County and the Honorable Margaret Costanza of Monroe County as Permanent Secretaries of this College.

PERMANENT PRESIDENT CAREY:

The Chair recognizes the Honorable John Stopen of Onondaga County.

HONORABLE JOHN STOPEN:

The next order of business is the casting of ballots for the President of the United States. The Chair recognizes the Honorable Betty Fisher of Kings County.

HONORABLE BETTY FISHER:

Mr. President, it is my privilege to present the motion that we proceed with the balloting for President of the United States.

PERMANENT PRESIDENT CAREY:

The Chair recognizes the Honorable Agnes Hayes of Queens County.

HONORABLE AGNES HAYES:

Mr. President, I am pleased to second the motion of the Honorable Betty Fisher.

PERMANENT PRESIDENT CAREY:

It has been moved and seconded that we proceed with the balloting for President of the United States. All in favor signify in the usual manner. (Chorus of ayes) Opposed? (None) The motion is carried.

The Chair appoints the Honorable Norman Goodman of New York County and the Honorable Eleanor Charles of Rockland County, as Tellers, to count the votes which are to be cast. Will the Tellers please take their places by the ballot box.

The Chair now recognizes the Honorable Marvin Greenberg of Kings County.

HONORABLE MARVIN GREENBERG:

Mr. President, may I suggest that when the balloting takes place the ballot box be taken to the Permanent President of the College so he may be given the honor of casting the first ballot for President of the United States.

PERMANENT PRESIDENT CAREY:

I thank you for this honor. Hearing no objection, I accept the honor.

May I suggest to the electors, please sign your name on the back of the ballot so that it may be returned to you as a memento of this occasion. I would ask you to come up to cast your ballot for President of the United States.

(Whereupon, the balloting took place.)

It appears all ballots have been cast. I request the Tellers to count the ballots and announce the result.

HONORABLE NORMAN GOODMAN:

Mr. President, after counting the ballots we find 41 votes cast for Jimmy Carter for President of the United States. (Applause)

PERMANENT PRESIDENT CAREY:

The Chair announces that the entire membership of the Electoral College of the State of New York has cast their ballots for the Honorable Jimmy Carter as President of the United States

The Chair now recognizes the Honorable Jay L. Turoff of Kings County.

HONORABLE JAY L. TUROFF:

Mr. President, I move we now proceed with the balloting for Vice President of the United States.

PERMANENT PRESIDENT CAREY:

The Chair recognizes the Honorable Frances Miseyko of Suffolk County.

HONORABLE FRANCES MISEYKO:

Mr. President, I take pleasure in seconding the motion.

PERMANENT PRESIDENT CAREY:

It has been moved and seconded we proceed with the balloting for Vice President of the United States. All those in favor signify aye. (Chorus of ayes) Opposed? (None) The motion

is carried. Be sure to sign your ballot so it may be returned to you by the Secretary of State as a souvenir of this occasion. I ask you to come up to the ballot box and cast your ballot.

(Whereupon, the balloting took place.)

All ballots having been cast, I ask the Tellers to count them and announce the result.

HONORABLE ELEANOR CHARLES:

Mr. President, after counting the ballots we find 41 votes cast for the Honorable Walter F. Mondale for Vice President of the United States. (Applause)

PERMANENT PRESIDENT CAREY:

Thank you. The Chair announces the membership of this Electoral College has voted unanimously for Walter F. Mondale as Vice President of the United States. At this time I ask each member of the college to sign the certificates of election which will be sent to Washington to attest to our actions here today, therefore, please come up to the dais to sign the certificates which have been prepared for your signature.

(Whereupon, the members of the Electoral College signed the certificates.)

I am advised by our Permanent Secretaries that the certificates have been duly signed by each elector of this Electoral College. The Chair recognizes the Honorable Morton M. Haves of Nassau County.

HONORABLE MORTON M. HAVES:
